BELLEOFTHEVALLEY stalked the pace three deep, launched his bid four wide, opened clear with a furlong to run, drifted out under left handed urging through the drive and was fully extended to just last. CRYPTO WARRIOR made a long drive circling five wide, loomed large entering the stretch, and was getting to the winner with every stride despite being carried out through the final yards. SID'S BEST HOUR sprinted clear to set the pace, weakened entering the stretch but had enough left to hold the show. REGISTRY made a middle move five wide, offered a mild bid but lacked the needed late response. PROCERITY made a mild rally from between horses but failed to seriously threaten. THREE M EXPRESS saved ground to little avail. RELENTINO showed little. ROBINHILL was through before going a half. The jockey of CRYPTO WARRIOR lodged an objection against BELLEOFTHEVALLEY for alleged interference through the drive, but following the Steward review there was no change to the order of finish.
