KING OF SPEED stumbled at the start, raced three wide on the first turn, tracked the pace on the outside, made a bid while three wide on the far turn, inched clear entering the final furlong and proved best under strong urging. SLEW BY SLEW raced four wide on the first turn, settled on the outside, made a bid while four wide on the far turn and was outfinished while able to secure the place. PRECIOUS COLONY prompted the pace on the outside, vied between rivals on the far turn and weakened while clear for the show. MR. SHOCK AND AWE dropped well behind the field, raced three wide on the far turn and failed to rally. GOOD OFFER raced three wide on the first turn, was ridden along on the backstretch and failed to respond. BID SPOTTER set the pace on the inside, dropped out nearing the quarter-pole and stopped. GRANDA TORMENTA was through after a half-mile and retreated.
