WIN ME OVER rated in the middle of the pack, ranged up into the turn and made a mild rally. RAVENSWORTH showed no speed, saved ground then closed willingly inside. ART OF DIPLOMACY was allowed to settle, angled out but was no threat. EARTHS VAIN SHADOW was void of speed, saved ground and was no factor.
