Footnotes

KING OF SPEED forwardly placed from early on, came four wide around the second turn, angled out entering the drive, was steered inside the leaders inside the furlong marker, drifted out to brush with GOWDEN MILE while prevailing. GOWDEN MILE between foes early, split foes midway down the backstretch, bid inside DUMBLEDORE around the second turn, gained the edge, exchanged brushes with KING OF SPEED late and missed. DUMBLEDORE set the pace while off the rail, responded when headed by GOWDEN MILE around the second turn, then gave way grudgingly. GANGBUSTER inside to the drive, moved out and passed beaten foes. BLACK DIAMOND BAY raced wide. GESTE showed early foot, then faded. EL INDY forwardly placed along the inside to the second turn, dropped back.
