PROUD GARRISON was in a good position stalking the pace three deep to the stretch, bid outside the runner-up past midstretch and wore down that rival under urging. ROCKIN ROSE stalked outside a rival, came out into the stretch, gained the lead outside a foe in midstretch, fought back off the rail through the final furlong and continued willingly to the wire. STATELY APPEAL chased inside then a bit off the rail, came out into the stretch and gained the show. THUNDER AND ICE went up inside to duel for the lead then inched away on the backstretch, set the pace along the rail, fought back in midstretch and weakened but lost third late. DEBATING SOCIETY stalked the pace between horses, came out some in the stretch and lacked the needed rally. PERFECT CAST saved ground tracking the pace, came off the rail in the stretch and weakened. CARBELLA between horses early, stalked a bit off the rail to the stretch and also weakened.
