Footnotes

POCKETOPENNIES rated just off the pace about the three path, advanced to the lead approaching the final turn, maintained a clear advantage through the turn then widened to midstretch of her own initiative for an easy win. SANDIE SILVERROD rated off the pace outside, bid into the final turn and proved much the best in place while not a threat to the winner. MISSAPPROVED rated off the pace inside, bid into the final turn then leveled off in the lane. WILLOW TWIST had a slim lead inside the opening turn then faded nearing the final turn. FASTER rated off the pace about the five path and had no response the final turn. FLOWING WATER advanced to a short lead entering the backstretch but faded after five eighths. BUTTERFLY HEART was pulled up in apparent stress and vanned off post race.
