ANTRIM COUNTY exchanged brushes with TEMPLAR'S CUP going to the first turn, settled while outrun around the turn, came inside around the second turn while advancing, awaited room nearing the drive, got steered outside TEMPLAR'S CUP approaching the final sixteenth and prevailed. TEMPLAR'S CUP exchanged brushes with ANTRIM COUNTY going to the first turn, raced three wide around the turn, split foes while moving up midway around the second turn, bid three wide entering the lane, moved clear and to the rail but was caught. ZENATO set the pace to the drive, then saved the show. CAPTAIN ABOVE stalked ZENATO from early on and then had no final kick. TACO TODDY four wide around the first turn, settled off the rail and had no response. MY POCKET five wide around the first turn, came three wide around the second turn, then faded. RAPATAPTAP showed early foot, then dropped back.
